

BOARD OF DIRECTORS APPLICATION AND POSITION DESCRIPTION

Overview

The Board of Directors is responsible for overall policy and direction of the Arkansas Center for Nursing, Inc. (ACN) and delegates responsibility of day-to-day operations to the staff and committees. Board members serve the ACN as volunteers and receive no compensation other than approved expenses. Board members serve a term of three years and are eligible for re-election for one additional three-year term.

Who may serve on the Board?

According to the ACN Bylaws, the Board of Directors consists of both elected and appointed positions. Elections and appointments are rotated on a three-year cycle so that there is always a mix of new and experienced members on the Board.

Elected Board positions: Elected or re-elected by a simple majority of the membership.

- Three (3) at-large representatives from the Individual Members (at least two direct-care providers),
- Two (2) representatives from nursing education programs, and
- Three (3) representatives from the Organizational Members (one each from a healthcare organization, a professional nursing association, and a nursing education program).

Appointed Board positions:

- One (1) designee from each standing committee,
- One (1) representative from the Arkansas Department of Workforce Services, and
- One (1) healthcare consumer.

Responsibilities and Duties of Board Members

Board positions require a time and energy commitment that should not be underestimated. Candidates are urged to consider personal and professional priorities over the next three years as well as ways to contribute to the development of the ACN. The ACN Policy Handbook specifies the following responsibilities and duties for its Board members:

General Responsibilities

1. Overall governance of the Arkansas Center for Nursing, Inc. by establishing and monitoring policies and programs and supporting development and effectiveness of the Board of Directors.

- 2. Establish the strategic purpose and direction by participating in strategic planning by the Arkansas Center for Nursing, Inc. and monitoring performance toward the plan's results.
- 3. Supervision of the Executive Director by hiring and monitoring performance toward the Executive Director's general responsibilities and yearly objectives.
- 4. Fundraising by planning and participation to secure necessary resources to support operations, programs, and services.
- 5. Represent the Arkansas Center for Nursing, Inc. and its programs and services to stakeholders, including the community, funders and clients.
- 6. Perform due diligence to secure the financial health of the Arkansas Center for Nursing, Inc. through conformance to up-to-date fiscal policies and procedures and through ongoing analysis of financial reports.
- 7. Perform due diligence to support the effective performance of the Arkansas Center for Nursing, Inc.'s programs through ongoing program planning and evaluation.
- 8. Perform due diligence to act in conformance to federal, state, local and the Arkansas Center for Nursing, Inc. policies and procedures.

Specific Duties

- 1. Member of the Board of Directors.
- 2. Abides by the Articles of Incorporation, Bylaws, and Board policies.
- 3. Builds collegial working relationships that contribute to consensus.
- 4. Contributes financially to the nonprofit organization, as appropriate.
- 5. Attends 75% of the Board meetings and related meetings.
- 6. Makes a serious commitment to participate actively in Board and committee work.
- 7. Volunteers for and willingly accepts assignments and completes them thoroughly and on time.
- 8. Stays informed about Board policies and committee matters, prepares themselves well for meetings, and reviews and comments on minutes and reports.

To Apply for a Board Position

- 1. Please take the time to learn about the mission and priorities of the ACN. Familiarize yourself with the bylaws and strategic plan of the organization.
- 2. Consider the ways that you may contribute to the work of the ACN. As a new organization, there is much work to do to ensure stability and sustainability for the future.
- 3. Reflect on the time and energy commitment required during your term as a Board member. Board members, committee chairs, and members give of their time, skills, and resources to ensure the success of our mission and programs.
